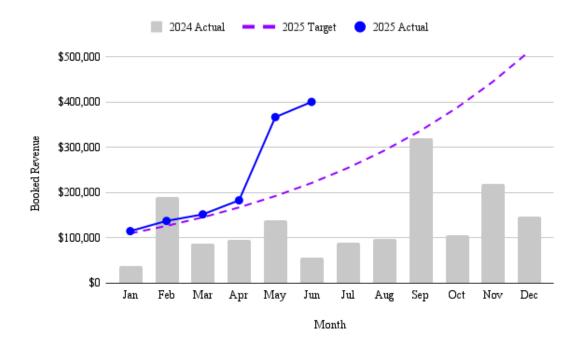
With momentum across sales, product, and our American Heart Association<sup>®</sup> (Heart Association) collaboration, we're now positioned to scale what's working.

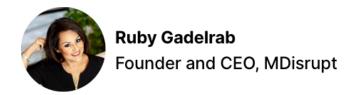
